I. INTRODUCTION

Sections 66001 and 66006 of the Government Code require that Eastside Union School District ("School District") provide to the public information on impact fees received from new residential and commercial/industrial development to mitigate the impact of that new development on the school facilities of the School District. The School District currently collects statutory school fees ("Statutory School Fees") pursuant to Sections 17620 et seq. of the Education Code and Sections 65995 et seq. of the Government Code.

The School District is required to provide the following information on Reportable Fees for the prior fiscal year:

- 1. Amounts collected
- 2. Amount of interest earned
- 3. Amounts spent on projects to accommodate additional enrollment from new residential and commercial/industrial development

The Reportable Fees do not include special tax proceeds, proceeds of bonds, or letters of credit to secure payment of Reportable Fees at a future date. Further, the School District identifies Reportable Fees have not been levied, collected, or imposed for general revenue purposes.

Additionally, the School District is required to identify the following:

- 1. The purpose to which unexpended Reportable Fees will be spent
- 2. The Reasonable Relationship between the unexpended Reportable Fees and the purpose to which they are to be spent
- 3. The funding sources and expected funding availability date for school facilities projects for which unexpended Reportable Fees are required

The following Annual and Five-Year Reports ("Reports") for the fiscal year ending June 30, 2021 include the information and proposed findings the School District intends to review and adopt in accordance with Sections 66001 and 66006 of the Government Code.

II. ANNUAL REPORT

In accordance with Government Code Section 66006(b)(1) and (2), the School District hereby presents the following information for fiscal year 2020/2021 (i.e. July 1, 2020 through June 30, 2021) with regard to the annual Reportable Fees:

A. <u>Description of the Type of Reportable Fees in the Account or Sub-account(s) of the School District</u>

The Reportable Fees of the School District for fiscal year 2020/2021 consist of Statutory School Fees. Statutory School Fees are collected by the School District from new residential and commercial/industrial development.

B. <u>Amount of the Reportable Fees</u>

The amount of Reportable Fees is based on the effective Statutory School Fees.

Statutory School Fees

The Statutory School Fees for the period effective July 1, 2020 through June 30, 2021 were established by the Board of Education ("Board") of the School District on March 28, 2016, by Resolution No. 15-16-20. This resolution adopted the Statutory School Fees for new residential and commercial/industrial development based on the reports titled "Residential Development School Fee Justification Study" and Commercial/Industrial Development School Fee Justification Study," both dated March 16, 2016 (collectively, the "Studies").

Table 1 belowlists the fee amounts and effective dates for the applicable Statutory School Fees for fiscal year 2020/2021.

III. FIVE-YEAR REPORT

In accordance with Government Code Section 66001, the School District provides the following information with respect to the Reportable Fees in the account or subaccount(s) remaining unexpended, whether committed or uncommitted to projects:

A. <u>Identification of the Purpose to which the Reportable Fees are to be Put</u>

The purpose of the Reportable Fees imposed and collected on new residential and commercial/industrial development within the School District was to fund the additional school facilities required to serve students generated by new development within the School District. Specifically, the Reportable Fees will be used for the construction, expansion, and/or acquisition of additional School Facilities, furnishing and equipping such facilities, as well as acquiring and installing additional portable classrooms to accommodate students.

B. <u>Demonstration of a Reasonable Relationship Between the Reportable Fees</u> and the Purposes for which they are Charged

There is a roughly proportional and a reasonable relationship between the new development upon which the Reportable Fees are charged and the need for additional School Facilities. This relationship is based on the additional students that will be generated by new development within the School District exceeding the School District's existing student capacity. Furthermore, the Reportable Fees do not exceed the costs of providing school facilities for the students generated from the development in which such fees were collected (as set forth in the Studies, referred to herein Section II.B).

C. <u>Identification of All Sources and Amounts of Funding Anticipated to</u> <u>Complete Financing of the School Facilities the School District has Identified in the School District's Reports</u>

Table 5 on the following page lists the proposed funding sources for all pending School Facility projects presently identified by the School District.
