Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. Professional Development

Eastside Academy supports the Common Core State Standards and 21st century instruction through a carefully planned staff development schedule. Teachers are provided planning time to review student performance of common formative assessments, and align instruction via the PLC process.

Eastside Academy uses general staff meetings, grade level meetings, monthly math workshops, and district PLC days to promote and support staff professional development. Teachers are granted the opportunity to learn about student engagement, breadth of knowledge, AVID strategies, leveled questioning, Depth of Knowledge, Core Academic Conversation Skills and common formative assessments. Teachers are able to meet with their peers regularly throughout the month, where they are prompted to collaborate in professional learning communities to answer questions such as: What do we want our students to know? How are we going to know that they learned it? What are we going to do when they don't learn it adequately, and what are we going to do when they do learn it adequately? Furthermore, they utilize this time to analyze data from common formative assessments.
